Restoration of Rights Reset Program  
Distomo

Decree article number : 2020/21/06/0001REST

Following the offer made to restore the rights of the creditors within the area  
known as Distomo

The following conditions will be applied.

Economic Strategy

1. Tax relief for all businesses by implementing the Kindness Credits  
currency into the community as accepted tender.

(i) This shall be completed by no later than 31<sup>st</sup> June 2020 and all shops and  
outlets will give the option to “Pay with Kindness Credits”

An area within the Town Hall building will be made available for the  
community to exchange their currency into the local currency and to settle  
their accounts replacing the banks, which are now obsolete, using their share  
of the planet represented by the token of the rock.

(ii) Kindness Credit Cards will be created using the tax paid to date by the  
residents of Distomo to relieve them of their tax burden.

An electronic card processing structure, will be credited by the people using  
their products and services to then exchange directly removing the  
interception and intrusion of AADE and Deutschbank and CEB in their private  
affairs.

(iii) All participants will have their electricity and water and debt discharged  
in return for them giving 5 hours a week to the community to help one  
another.

(iiii) The tax paid by all residents in the last 80 years will be calculated and  
used as Surety for those wishing to exchange their Kindness Credits back into  
slave tokens to interact with communities not yet established with Kindness  
as a currency.

2. The charges that have been paid unlawfully to EDAP since it began  
charging, will be refunded to the Town Council on behalf of the residents  
for the unlawful trespass upon their supply and the toxification of the  
resource by adding chemicals to it.
3. Part of the funds refunded shall be used to create the connection of the  
village to the water supply from Panassos that stops 5 km out of the

- village and for the filtration of any heavy metal particles that cause contamination. By no later than September 30<sup>th</sup> 2020
4. Workers on this project shall be settled with Kindness Credit notes that they can convert into Euros through the Town Hall's Kindness Credit "Banking" Service. Using the tax refund to credit their Euro currency bank accounts.
  5. The five hours a week shall form an Energy Exchange and a designated building will operate the exchange where oil honey wine and other products will be exchanged for those giving their time on completion of a Kindness Credit Claim form for each household per week or month.
  6. Surplus "stock" shall be sent to Athens "toll free" to support the communities there while they integrate the same changes. This shall be known as a Kindness Credit Conversion.
  7. Those still converting their energy in to slave tokens in Athens and other places will convert their slave tokens into Kindness Credits to be able to afford the produce more freely. This will be held in a designated holding account and provide the creditors there with surety services

#### Education Strategy

1. The children now attending the schools in Sept 2020 will be given a "Reboot Your Hard drive" and it will be for the children to decide what they want to learn.
2. Part of their choices will be Economics. Universal Law and unalienable rights. Commerce. Farming and Bio Ethics Law as well as Free Energy Engineering
3. Between today's date and the beginning 1<sup>st</sup> August 2020 children between the age of 6 and 16 will be asked to complete a questionnaire asking them what it is they would like to be taught and how they would like to be taught.
4. The questionnaire will have suggestions but also space for them to suggest to the community what they would like to see happen with their share of this planet.
5. Between 1<sup>st</sup> Aug and 1<sup>st</sup> Sept 2020 consultants ( once known as teachers) shall be able to apply for the roles of teachers and it will go to a direct democratic vote of the children as to who they choose to teach them what. This shall begin on the 1<sup>st</sup> of September and be held in the Town Hall and the children shall host it and manage it as a Project Reset Distomo or whatever they choose to name it.
  - (i) The resources required for teaching the children shall be covered by the restoration of rights package through the tax relief, the refund of the water charges and the restoration of rights of the creditor compensation that shall come from the funds of the electricity that has been generated here in Distomo that DEH has claimed as profit.

Restoration of the rights of the Residents of Distomo.

The war over the resources provided by Ellada / Earth costing so many lives and causing so much pain can never be compensated. The loss of life and liberty that had been continued all this time is now to be remedied. It is for the people of Distomo to define how and what shape that will take.

We suggest as the Asset management of the Secured Party Creditors that the trespass upon the rights of the resources of the energy and mineral excavation ceases with immediate effect and the mine is to be closed.

With exception to the part where the energy is being created by sea water, however the use of chemicals destroying the sea life will cease and desist.

In place the people working there destroying their own environment for slave tokens will now be able to rest and know their liabilities are covered by this restoration process and engineers and workers will determine how they want to grant their 5 hours creating an energy turbine that does not cause harm.

The extraction of gas will cease and those involved in the process will have new roles created for them, by them determining what they would like to see in place of the rape of our planet for profit as it is no longer required.

The transition period will be covered by the refunding of the profits made through this exercise by a collateral swap of the airports and seaports back into the creditors accounts by the tax claimed by AADE for the transportation of all private people since 2008

The buildings that are run down will be restored and a right of use granted to anyone who wishes to support this process.

The gardens and land will be put to a right, right of use to produce the food to support the community on a third of the share of the harvest basis.

A third goes to the families who produce the crops to do with as they see fit. A third goes to the communities old sick weak and infirm or disabled and a third goes to the shops and is sent to other communities.

Which will set Distomo up be a landmark on the map for this initiative attracting people from all over the world to witness this free energy project. Attracting tourism and our families back from having to abandon their assets to go and work in the cities away from their families.

This will build tourism and the Kindness "economy"

Big Blue Asset management will help to manage the restoration of the buildings that were built to facilitate free slaves working in the mines and a right of use will be issued for this purpose. No one is claiming anything just helping one another to use what they have a right of in a more effective way.

The buildings in the South East of the village are to be used to create a healing sanctuary for old, sick and or infirm as well as host to those

coming to learn the Distomo Kindness credits Structure as a training centre for them to then take back to their own communities across Earth to install and implement the projects there.

The materials to restore this will be donated by the companies that profited from the sweat equity of the workers who once worked there. I.e. the families of the previous generations of those people of the village.

Distomo Beach will be restored using building materials donated from the Aluminium works after it is closed. This area will be used as the community decide.

One suggestion is to hold a meeting there every week in the summer to have an open forum where everyone gets to share their ideas and or issues that will be dealt under Universal Law and the parties shall be the judges of themselves with all evidence laid before a hearing is heard to establish grounds.

Peoples protection patrol the state police will be renamed Peoples Protection Patrol and cease in enforcing commercial code upon the people and only be involved when there is a victim and or loss harm or damage keeping the peace, not breaking it.

#### Crops

Organic Hemp will be planted in large crops and used for manufacturing clothes and the equipment to process the crop into all its parts will be covered by AADE for the unlawful claim of tax liabilities since 2008.

Including but not exclusively the full spectrum variety to protect against cancer.

A full audit of accounts will establish the ledgers and this information will be made public

Again a third of the share of the harvest will be implemented.

#### Health care.

The buildings that are empty will be restored and used to provide Homeopathy and Natural Remedies by Bio Ethic trained healers and a surgery for breaks and minor injuries will be dealt with inhouse.

A rehabilitation program for those effected the most by the past experiences will be initiated and the 5 hours a week of the people will create this with support workers, health care and therapists.

The distribution of chemicals in the name of medicine will be made obsolete and the creation of natural remedies will replace it.

This will open up exchange of skilled people coming from other communities to share their knowledge and expertise in all matters.

The transmitters radiating the people with any EMF above 1 HTZ will be dismantled the internet is hardwired and is free due to the debt that Cosmote and Vodafone have here in Ellada with the people and street

lights that have been fitted with LED will be removed and the low down lights replaced to prevent light pollution and harmful rays.

All charges and claims made against those which are victim less crime are to be released and all claims quietened all debt is forgiven.

Coronavirus will be dealt with by Universal Law Community Trust remedy (patent number 88359) and ministered to those who would like to receive it and an immunity certificate issued.

Minister EMOVEN cards will be given out that reserve the rights of the bearer reserved and all data protected behind it in a Kindness credit ledger accounting system. This is for those that wish to reconfirm their contract with the Universe and to go about their lives in the private.

This will quieten all claims to any corporate owned titles and the system of fiction shall cease to exist.

Ellada restoration shall begin with the removal of the trespass on sacred sites by AADE and UNESCO and the equipment there is classed as The "sale" of Ellada to private corporations through selling the assets of the planet without being granted rights of use to do so by the people will cease immediately and all funds raised to date are to be credited to a holding account names Ellada Kindness Credits Trust and this will restore the rights of the true creditors of the worlds stock exchange.
