ORDER

UPON my determination in case ref CO/3484/2921 on the 27.10.21 that no proof of claim, evidence, witness testimony and first -hand accounts and sworn statements are required in order to lay claims with

AND UPON my disregard of the point of fact that when a party retires their consent from a n other to act on their behalf a claim can still be continued and does not cease or desist

AND UPON my determination to disregard and discount the act of fraud that would normally be associated with “a n other” utilizing equitable rights implied to belong to “a n other” void of valid assignment of consent

AND UPON my determination that should someone take something that is not theirs and use it as if it was not being considered to be unlawful any longer

AND UPON my administrative clerks dissolving Surety by determining that each has to stand surety to themselves and no one can stand surety to a n other, rendering Mercantile Law void and all other contracts

I granted the right of use of my equitable rights to any other party identifying as Minister Emoven to utilize my title to imply they are acting on my behalf the deed was recorded

IT IS ORDERED THAT

1. that all equitable rights of all legal fictions have been assigned unto the jurisdiction of Universal Law and that those who are still openly implying they consent to supporting terrorism by using legal fiction titles copyrighted by HMG CROWN CORPORATION and all other agents thereof to be guilty of fraud and false claim.
2. APPORHITO LTD to act as the interpleader in all matters regarding the Restoration of Rights of the Creditors and I order that all orders made by Universal Law Community Trust through the Ministry of Remedy Divine Writs be complied with
3. My determination that was recorded in the aforementioned case is to be made public
4. that any agent previously employed by agencies of HMG who are not performing the requirements set out by BBAM and APPORHITO agents are considered to be in contempt of court and to be immediately imprisoned for a period no less than 3 years at a suitable venue to be rehabilitated.
5. The cost of this will be discharged through the equitable rights that are to be assigned back unto Universal Law and all other registration process other than that at BBAM.rocks is forbidden and unlawful and that all parties currently incarcerated for NON VICTIM CRIME are to be released with immediate effect
6. Those agents not complying are to be arrested by PPP Peoples Protection Patrol who have been assigned the consent to replace to private police companies and all authority is once again back in the hands of the people
